School Family Engagement Policy

PART I. GENERAL EXPECTATIONS

Patrick F. Taylor Science and Technology Academy agrees to implement the following statutory requirements:

- Consistent with section 1118, the school will work to ensure that the required school level family engagement policies meet the requirements of section 1118 of the ESEA, and each include, as a component, a school-parent compact consistent with section 1118(d) of the ESEA. (See Enclosure)
- Schools will notify parents of the policy in an understandable and uniform format and, to the extent practicable, in a language the parents can understand. The policy will be made available to the local community and updated periodically to meet the changing needs of parents and the school.
- In carrying out the Title I, Part A, family engagement requirements, to the extent practicable, the school will provide full opportunities for the participation of parents with limited English proficiency, parents with disabilities, and parents of migratory children, including providing information and school reports required under section 1111 of the ESEA in an understandable and uniform format and including alternative formats upon request and, to the extent practicable, in language parents understand.
- If the school-wide program plan for Title I, Part A, developed under section 1114(b) of the ESEA, is not satisfactory to the parents of participating children, the school will

submit any parent comments with the plan when the school submits the plan to the local educational agency (school district).

- The school will involve the parents of children served in Title I, Part A schools in decisions about how the 1 percent of Title I, Part A funds reserved for family engagement is spent, and will ensure that not less than 95 percent of the 1 percent reserved goes directly to the schools.
- The school will build its own and the parent's capacity for strong family engagement, in order to ensure effective involvement of family and to support a partnership among the school, parents, and the community to improve student academic achievement.

(C) that parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;

(D) the carrying out of other activities, such as those described in section 1118 of the ESEA.

PART II. DESCRIPTION OF HOW SCHOOLS WILL IMPLEMENT REQUIRED SCHOOL FAMILY ENGAGEMENT POLICY COMPONENTS

1. **Patrick F. Taylor Science and Technology Academy** will take the following actions to involve parents in the joint development of its school family engagement plan under section 1118 of the ESEA:
 - *Parents will be invited to attend a Title I Night to review the plan.*
 - *Parents will be invited to attend a FAFSA night.*
 - *Parents will be invited to attend a TOPS night.*
 - *Parents will be able to attend virtual Parent Teacher Conferences in the Fall and in the Spring.*
 - *Parents will receive the electronic weekly announcements via PAW Prints as well as the monthly school newsletter.*

2. **Patrick F. Taylor Science and Technology Academy** will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:
 - *Parent Title I Night*
 - *Parent Survey at the end of the year*

3. **Patrick F. Taylor Science and Technology Academy** will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional family engagement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:
 - *Date to be determined - postponed due to Hurricane Ida*

4. **Patrick F. Taylor Science and Technology Academy** will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:
 - *Teacher's individual class syllabi will include the above mentioned information.*

5. **Patrick F. Taylor Science and Technology Academy** will, at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

- *Responding to emails and phone calls within 24 hours.*
6. **Patrick F. Taylor Science and Technology Academy** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
 - *Sending home the information as soon as that information is provided to the school.*
 7. **Patrick F. Taylor Science and Technology Academy** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
 - *Email from administration*
 8. **Patrick F. Taylor Science and Technology Academy** will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --
 - the state's academic content standards,
 - the state's student academic achievement standards,
 - the state and local academic assessments including alternate assessments,
 - the requirements of Part A,
 - how to monitor their child's progress, and
 - how to work with educators:
 9. **Patrick F. Taylor Science and Technology Academy** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster family engagement, by:
 - *Information available upon request.*
 10. **Patrick F. Taylor Science and Technology Academy** will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - *Creating a welcoming environment for the parents and implementing a system of open communication between the parents and the school.*

11. **Patrick F. Taylor Science and Technology Academy** will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

- *Information will be sent out via PAW Prints, email, and post office.*

PART III. DISCRETIONARY SCHOOL FAMILY ENGAGEMENT POLICY COMPONENTS



- adopting and implementing model approaches to improving family engagement;
- establishing a school parent advisory council to provide advice on all matters related to family engagement in Title I, Part A programs;
- developing appropriate roles for community-based organizations and businesses, including faith-based organizations, in family engagement activities.
