

# School Family Engagement Policy

## Ray St. Pierre Academy

### PART I. GENERAL EXPECTATIONS

The **Ray St. Pierre Academy** agrees to implement the following statutory requirements:

- (C) that parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;
- (D) the carrying out of other activities, such as those described in section 1118 of the ESEA

## **PART II. DESCRIPTION OF HOW SCHOOLS WILL IMPLEMENT REQUIRED SCHOOL FAMILY ENGAGEMENT POLICY COMPONENTS**

2. St. Pierre Academy will take the following actions to involve parents

*Parents and family members will be invited to participate in the following (depending on restrictions imposed by the governor/Parish):*

- Literacy Night/Math & Science Night
- Spirit Nights at Chick-fil-A and Texas Roadhouse

- Dads & Donuts/Moms & Muffins
- Father Daughter Dance
- Pops & Popsicles
- Movie Night
- Field Trips
- School-wide fundraisers

3. St. Pierre Academy will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional family engagement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:

*Parents will be invited to attend the meeting via email, the school website, and individual grade level and/or teachers' Google Classrooms. The meeting will also be advertised in the **monthly school-wide publication.***

4. St. Pierre Academy will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:

*Teachers will send each student's parents a **Welcome letter** outlining the expectations regarding curriculum, testing and proficiency/grading requirements. A Parent Handbook: **Procedures and Policies for Parents and Students** is available on JPSchools.org and the JPSchools app. These documents are also accessible on our school website: [jpschools.org/stpierre](http://jpschools.org/stpierre).*

5. St. Pierre Academy will, at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

*Parents are encouraged to use all **Parent Conference** opportunities as well as communicate with teachers via **email** and a **weekly communication folder**. The expectation is for teachers to respond to parent inquiries within twenty-four hours. We also give parents a copy of the School Parent Compact and Family Engagement Policy.*

6. St. Pierre Academy will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

*Parents of students who take State assessments will receive a student report by the beginning of the following school year.*

7. St. Pierre Academy will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

*Parents of students who have been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified will be notified in writing. All teachers currently on staff at RSPA are highly qualified.*

8. St. Pierre Academy will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --

- the state's academic content standards,
- the state's student academic achievement standards,
- the state and local academic assessments including alternate assessments,
- the requirements of Part A,
- how to monitor their child's progress, and
- how to work with educators:

*Parents of students in testing grades will be invited to a **LEAP Parent Night** to support their understanding of academic content standards, academic achievement standards, and state and local academic assessments. Parents will also be notified of any and all **opportunities for training offered by Title I**. Parents will be invited to attend the **Parent Advisory Committee Meetings**.*

9. St. Pierre Academy will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

*St. Pierre Academy will support the efforts of its parent groups (P.T.O./Dad's Club) by holding bimonthly meetings after school hours.*

10. St. Pierre Academy will, to the extent feasible and appropriate, coordinate and integrate family engagement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs. The school will also conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:

*St. Pierre Academy will support these programs and offer additional opportunities for parent involvement and participation to the greatest extent possible..*


- Involving parents in the development of training for teachers, principals, and other educators to improve the effectiveness of that training;
